***ALL APPLICANTS MUST READ AND SIGN THE FOLLOWING:***

Because of these and other hazards, every club member must obey the Miniature Aircraft Association of Westchester field safety rules, & the Academy Of Model Aeronautics safety code AT ALL TIMES, and show good judgment accordingly when at the field.

By signing this form you agree to hold the Miniature Aircraft Association of Westchester, its Officers and Directors, and the Westchester County Parks Dept. harmless in case of any damages or injuries you may suffer as part of your participation in RC flying, modeling and club activities with the MAAW, including flying alone as a certified solo pilot at the MAAW field.

Attention- Parents of Junior members: The MAAW is NOT responsible for minor children. A parent or guardian must be present whenever a child under 16 years of age is at the field. Parents must decide if their child is ready to handle the responsibilities of Radio Controlled Modeling. Final decision regarding a minor's suitability/capacity for RC flying rests with the club's Executive / Training Director. A parent or guardian must sign the application for anyone under 18 years of age.
