MAAW Membership is open to all. Responsible new members are always welcome! Visit our field or come to a meeting. There is an Initiation Fee of \$25, and yearly dues are \$100. Junior membership (16 years old or younger) is \$50 yearly, with no Initiation Fee.

>>> Academy Of Model Aeronautics (AMA) membership is required to join the MAAW. <<<

## REQUIREMENTS FOR MEMBERSHIP:

- 1) Proof of Westchester County residency- usually, your driver's license.
- 2) You must show a current AMA card or photocopy when you apply (see #5).
- 3) You must pay the yearly dues (and Initiation Fee if applicable) when you apply.
- 4) **All applicants must read and sign the notice on the back of this form.** A responsible adult must sign for a Junior member. Proof of residence is required.
- 5) **You must show a VALID 2024 AMA membership card, or electronic (email) confirmation of 2024 AMA membership- showing your AMA number- to receive your 2024 Field ID card.**

You must submit your application to the MAAW in person at the monthly meeting, or via other Arrangement with the Membership Director. Our meetings are held on the third Saturday of the month at either the Croton Colonial Diner or at the flying field.

APPLICATIONS: Senior Dues and Initiation Fee (1 time per new **or lapsed** application): \$125.00. Junior (under 16 years old) Dues: \$50.00. Make all checks payable to MAAW.

ALL APPLICANTS MUST READ AND SIGN THE FOLLOWING:

There are certain hazards that are an inherent part of RC (Radio Controlled) model flying. There is a chance of injury from propellers, hot engines, batteries, chargers, fuels, glues and finishes used. There is also the possibility of being struck by a moving model, either in flight or on the ground. Because of these and other hazards, every club member must obey the Miniature Aircraft Association of Westchester field safety rules, and the Academy Of Model Aeronautics safety code AT ALL TIMES, and show good judgment accordingly when involved in any RC activities at the field.

By signing this form you agree to hold the Miniature Aircraft Association of Westchester, its Officers and Directors, and the Westchester County Parks Dept. harmless in case of any damages or injuries you or other parties may suffer as a result of your participation in RC Modeling & Club activities at the MAAW field, including flying alone as a certified solo RC pilot.

Attention- Parents of Junior Members:

The MAAW is NOT responsible for minor children. A parent or guardian must be present whenever a child under 16 years of age is at the field. Parents must decide if their child is ready to handle the responsibilities of Radio Controlled Modeling. Final decision regarding a minor's capacity to fly RC rests with the club's Executive / Training Director. A parent or guardian must sign the application for anyone UNDER 18 YEARS OF AGE.
